### FOR IN-PERSON ATTENDEES - MASK REQUIREMENT, WAIVER FORM, & FOOD ALLERGIES ALERT:

All events at the Northern Center must abide by state, CDC and university policies and guidelines. On Monday, August 23<sup>rd</sup>, the Marquette County Health Department confirmed that Marquette County's COVID classification has changed from "moderate" to "substantial." In line with the CDC's recommendation that all individuals, regardless of vaccination status, wear masks (over nose and mouth) when indoors in any areas that are at the substantial and high COVID levels, as of yesterday (August 24<sup>th</sup>), all individuals – vaccinated and not vaccinated – must wear masks when indoors at all Northern facilities unless actively eating and drinking. This includes both guests and event staff. Signage will be posted on all building entrances, as well as in the room, reminding individuals of the requirement. All in person attendees of the UP Training & TCHPC Cross Training at Northern Center will receive an MATCP Logo Mask.
